Why pre-planning matters

Recently I was in New Orleans for the Catholic Cemetery Conference and Convention. It was a wonderful experience to share a few days with other Catholic leaders who manage cemeteries throughout the country. While

there, I quickly realized that I was in a group of very good people who were all doing their best to serve families in their time of need. Their sense of care and compassion was palpable. It was a great opportunity to share ideas and concerns with others who are all dealing with similar issues. I think we all learned something from each other.

One of the points that I picked up was the great need to pre-plan one's funeral and burial

arrangements. We all know that this is important, but it is so easy to put it off. Our days get filled with many things, and we think that we can always do this planning tomorrow. Unfortunately, tomorrow does not come for all of us. We have to seize the moment when we have it. I have come to realize that there are two very important reasons to do pre-planning. The first is that we want to save our family from having to do this especially at the time of our death. That will be a difficult enough time for them even without having to make any decisions. Priests and funeral directors can tell you many stories of how stressful this can be on a family. It is so tough to pick out a casket and a cemetery plot when your mind is completely elsewhere. Many families just wish that someone else would make the decisions for them.

The second reason to do the planning is to make sure that your wishes are carried out. I know many good Catholic people who did not even

We need to write down or tell our family what we want, especially that we want a Mass in our parish so that the prayers of the Church will go with us on our journey to the Kingdom. Of course, there are many other issues to consider in planning our funeral. We will do everyone a favor by having our wishes clearly outlined.

I suspect that all of us are procrastinators to some degree, but let's not procrastinate about our funeral planning. We all know that we are going to die at some point. Do your family and yourself a favor by having everything in order. It is one last gift that we can give our loved ones.

Do you need to be Catholic to be buried in Catholic Cemeteries?

Catholic Cemeteries was created to provide the corporal act of mercy of burying the dead, specifically those of the Catholic faithful in the Archdiocese of Omaha. However, we have no intent to separate families. As a result, we have clients of many different faiths and denominations interred in our cemeteries. Our policies state that our clients should either be Catholic or have family members interred or planning to be interred within our cemeteries. This allows for families to be buried together regardless of their faith.


Our mission is to minister to individuals and families during one of the most difficult times in their lives, and to help them know that they aren't alone. I've had the privilege of being the director here at Catholic Cemeteries for a little more than two years. I've received feedback from many families regarding their interaction with our team, and the most common comment has been the feeling of how much our team genuinely cares about them.

About a year ago, we began including a marketing tag-line for our radio advertisements: "Catholic Cemeteries – Our Faith is at the heart of all that we do." This wasn't marketing lingo. Rather, it came to mind by watching and experiencing our team's interactions with our clients. We try to live our faith in all aspects of what we do. I believe Catholic Cemeteries is not so much a job for the members of our team – it truly is a ministry.

New road at Resurrection

If you've visited Resurrection Cemetery recently, you likely noticed there is a new north/south road through the middle of sections M, N and O. While this road has taken up space where graves could have been located in the future, it will allow easier access to the interior of these sections and will provide much sought-after roadside grave space.

Phase two of this project will include a sidewalk connecting the new road with Holy Angels Mausoleum. This will provide additional parking closer to the mausoleum for our monthly Memorial Mass and other larger gatherings. Both phases of this project also provide for additional "family estates", which are larger private areas that allow for unique memorializations such as statues and benches. Funeral rites for children

On May 25, 1980, my wife and I lost our son. He was born early and only lived a few minutes. The doctor had the grace to baptize Nathan right there in the room. My wife and I were so upset and not thinking clearly, I don't think we understood the gift he gave us. We had our son buried in the Serenity section at Calvary Cemetery – a section specifically created just for infants. I also know the sadness that many people have at the loss of a child before birth. Many have expressed their regret and pain because their child was not baptized. When I speak to them about this, I always share that when we hope and faithfully trust in God's Mercy, our children receive His graces.

The Church provides an adaptation of the principle funeral rite specifically for children and this adaptation includes "Vigil for a Deceased Child," "Funeral Liturgy," and "Rite of Committal," each tailored specifically for a child. These rites may be used in funerals for infants, young children, including those of early school age. The Church provides specific texts to use in the case of a baptized child and in the case of a child who died before baptism.

Regarding the little ones who have died before baptism, the Catechism of the Catholic Church in paragraph 1261 says: "As regards children who have died without Baptism, the Church can only entrust them to the mercy of God, as she does in her funeral rites for them. Indeed, the great mercy of God who desires that all men should be saved, and Jesus' tenderness toward children which caused him to say: 'Let the children come to me, do not hinder them,' allow us to hope that there is a way of salvation for children who have died without Baptism. All the more urgent is the Church's call not to prevent little children coming to Christ through the gift of holy Baptism."

Additionally, in the Order of Christian Funerals under Prayers for the Mourners, we read: "God of all consolation, searcher of mind and heart, the faith of these parents is known to you. Comfort them with the knowledge that the child for whom they grieve is entrusted now to your loving care." The Church deeply loves these little ones.

In an effort to walk with families who have lost a child, Catholic Cemeteries offers:

- Deacons to preside at committals for infants.
- In the fall and spring of each year in cooperation with CHI Health, Heafey-Hoffman-Dworak-Cutler Mortuaries, and Catholic Cemeteries, we offer a free communal infant committal service at St. Mary Magdalene Cemetery for those who have lost a child during pregnancy.
- The children are specifically remembered at the following month's Catholic Cemeteries Memorial Mass.
- We also offer grief programs several times a year to assist those who have experienced the loss of a loved one.

So many of us have experienced the loss of a child, whether in our own family or someone close to us. Many times, we just suffer the loss in silence. Even if it doesn't feel like it, know that God is with you and you are not alone.

We will gather November 29, December 6, 13 and 20 to pray the scriptures and ask for God's quiet in our hearts. We will continue our tradition of inviting you to write your petitions and place them on the Christmas tree, where all who enter this holy space might then pray for them. These petitions will be blessed and then after our January Memorial Mass they will be buried in our cemetery. I invite you to come visit Holy Angels Mausoleum, to listen to the chants, quiet your inner self, and bask in the memories our Lord places on your mind at this time of year. Catholic Cemeteries' staff will be praying for your peace as you continue the journey of your personal loss.

Our grief workshop "The Way" through Grief is offered several times during the year. It is a six-week workshop for those who are experiencing grief. This workshop recognizes that all of us will experience grief in our lives. We dare to move forward after the death of a loved one in faith, hope and love. Sometimes we just need a little guidance, direction and reminder of the life God wants for us. We've received tremendous feedback from prior attendees. "The Way" is a journey through grief using Jesus' journey of the Stations of the Cross through His resurrection. Fall-Winter decoration guidelines

Gravesites:

Appropriate artificial decorations may be placed Nov. 2 through March 31. Items such as grave blankets that cover the ground must be removed by March 1.

Vases:

We recommend that vases be left turned down in the cemeteries during the winter months.

Monuments:

Appropriate decorations may be placed year round on the base of an upright memorial as long as they do not interfere with the daily operations of the cemetery.

Mausoleums, Crypts, Niches:

Items can only be placed in or on an approved vase attached to a crypt or niche front. No items can be taped, wired or otherwise attached to the crypt or niche front. Fresh flowers are not permitted in a mausoleum, and will be promptly removed.

Inappropriate Items:

Items not conforming to Catholic Cemeteries' policies, items placed in the ground or those extending onto adjoining graves, crypts or niches will be removed without notice. Out of respect for our consecrated grounds, pets and smoking are not permitted.
